Ashley Hamilton: PIT Count updates: The PIT count takes place at the end of january in order to establish the number of homeless individuals residing year round within an area. This year there will again be a heavy emphasis on volunteers. Volunteers can sign up online or contact Polk County FCO.

Brent DeMoe: PIT count updates: There will also be increased involvement and emphasis on city and county employees filling out PIT count surveys and being trained on how to do so if possible. Law enforcement and Code enforcement are often already in contact with many of the homeless individuals within Polk county. Polk FCO staff will support and fill in where needed. Falls City may require some more specific planning to contact some isolated residents.
