- ➤ **Josh Graves** (Catholic Community Services) Putting up 60 affordable housing units in West Salem.
- ➤ **Josh Erickson** (Church at the Park) Did a ribbon cutting for family transitional shelter. 32 beds 9x9 lot. 76% of exits out of family shelter transitioned into housing.
- ➤ Michael Cherry (CTGR) New partnerships for 2024. Stratus village in McMinnville will be putting up 80 affordable housing units and CTGR will have 20 units for tribal members. New residential treatment center coming open in Sheridan before 2025 for tribal members.
- ➤ Brent DeMoe (Polk FCO) Edigar Hall. Have successfully moved 2 families into Edigar Hall and have exited them with long-term housing. Gales Lodge just received an 18-month grant from Oregon Department of Veteran Affairs, which allows Andrew (Polk County FCO staff for Veterans) to be full-time. HUD approved Housing Authority to have preference to families that are enrolled in Rapid Rehousing. Willamette Health Council spending 1 million dollars. \$250,000 goes directly to barrier funds for Service Integration and Polk County FCO. Some of the money will go towards food.
- Amy Houghtaling (Falls City) Resource Center will be built on the Mill Lot in Falls City to have office space, food distribution, and other services providers that are needed in

Falls City.
