 - ☐ Paused on work due to moving pieces with Governor's order and Emergency Funding. Now that those pieces are decided, will integrate elements of the Regional Plan and funded Polk County projects.
 - ☐ Will reconvene the small group to work on this.
 - ☐ We will shoot to have the Strategic Plan completed before the Fall.

 - ☐ Brent/Marriane ended up talking about the website. Should be ready to share in a few weeks.
- Municipality updates from members Discussion –All Members
 - ☐ Oregon Recovery Behavioral Health is now located in Dallas off of Court St.

 - ☐ Brent DeMoe mentioned the grand opening for Ediger Hall - a transitional housing project for families will be in mid June.
